To keep you updated on projects completed this year, the main work will focus on the renovation of the kitchen cabinets and counter tops in Buildings A, B, and C, scheduled to begin in the spring maintenance weeks. Wireless Upgrades

When Pyramid Software Solutions from Bonita Springs installed a wireless network at Tortuga about five years ago, the system was designed for people to check emails and surf the web on their laptops. Over time, however, more web features have become available along with more devices that connect to the web, like smart phones and iPads. To compound the problem, instead of a family bringing a single laptop on vacation, they are now bringing multiple devices, causing "over subscribing" and a strain on the older system.

Your Board has decided to greatly improve this situation and has asked Karl Schwaerzle of Pyramid to come to the rescue and install systems and equipment with three times the initial bandwidth to help manage the situation.

The Sanibel Captiva Conservation Foundation (SCCF) has worked tirelessly for decades to protect the unique nature of Sanibel and Captiva and curtail excessive growth.

Last June they entered into a one-year option

agreement to purchase the 28.3-acre Bailey Family Historic Homestead and wildlife habitat with a purchase price of \$4 million. SCCF needs to raise an additional \$400,000 to support the initial restoration and ongoing management of the land in perpetuity.

By March 14, total contributions had reached \$3.6 million but additional funds are needed by June 24 to protect the future of Sanibel. Log onto their website at **sscf.org** to obtain a donation form.
