## Maintenance Fees Due

Annual maintenance fees have been mailed to each Owner. Please be aware that your account will be considered past due on **February 15, 2012**. If you have not received your maintenance fee statement, please contact the Resort office at 239-472-0400 as soon as possible.

Failure to pay the total amount due within 45 days of the January 1 due date will result in a \$25 Late Fee. Payment must be **posted** to your account prior to **February 15th** to avoid this additional fee. **Remember that it can take up to ten days from the date of your envelope postmark before your payment is actually posted to your account. <b>Please don't wait until the last minute!** 

Failure to pay the total amount due prior to **April 1, 2012** may result in denied use of your ownership interest and the account may be turned over to an attorney for collections, resulting in additional expense.
